**Subject: Incorporation of condition in the label/leaflets by registrants holding CRs of the formulations Bifenthrin 10% SC, Deltamethrin 1.8% EC & 2.8% EC, Fenpropathrin 30% EC, Acephate 25% + Fenvalrate 3% EC, Chlorpyrifos 50% + Cypermethrin 05% EC Difenthiuron 47% + Bifenthrin 9.4% EC, Pyriproxifen 5% + Fenpropathrin 15% EC, Pyriproxifen 10% + Bifenthrin 10% SC -regarding.**

Reference is invited to the decision taken by the Registration Committee at Agenda Item No. 10.10 in its 428<sup>th</sup> meeting held on 18<sup>th</sup> May, 2021.

Accordingly, all the registrants holding CRs of the formulations Bifenthrin 10% SC, Deltamethrin 1.8% EC & 2.8% EC, Fenpropathrin 30% EC, Acephate 25% + Fenvalrate 3% EC, Chlorpyrifos 50% + Cypermethrin 05% EC Difenthiuron 47% + Bifenthrin 9.4% EC, Pyriproxifen 5% + Fenpropathrin 15% EC, Pyriproxifen 10% + Bifenthrin 10% SC are required to incorporate the following condition in label/leaflets :

*“The CR shall be the outcome of the studies to be carried out by the registrant after the protocols for the same would be approved by the RC and CR shall further be subject to outcome of those studies”.*
