## MINUTES OF 382<sup>nd</sup> MEETING OF REGISTRATION COMMITTEE HELD ON 12.12.2017 IN THE COMMITTEE ROOM NO. 1, ICAR, KRISHI BHAWAN, NEW DELHI.

The 382<sup>nd</sup> Meeting of Registration Committee (RC) was held under the Chairmanship of Dr. S. K. Malhotra, Agriculture Commissioner on 12.12.2017 at 10:30 AM in the Committee Room No. 1, ICAR, Krishi Bhawan, New Delhi at 10:00 AM. Dr. B.S. Phogat, Plant Protection Adviser; Dr. P. K. Chakrabarty, ADG (PP&BS), ICAR; Dr. K.K. Sharma, Network Coordinator, ICAR-AINP on Pesticide Residue, New Delhi; Dr. I.S. Sandhu (Representative of Drugs Controller General of India, M/o Health and Family Welfare, New Delhi); Dr. Rohit Mishra, Assistant Industiral Advisor, Ministry of Chemical and Fertilizers, Department of Chemical and Petrochemicals, Shastri Bhawan, New Delhi and Shri D.D.K. At the outset, the Chairman welcomed the members and requested APPA & Secretary, CIB&RC to take up the agenda, item-wise, for deliberation. APPA & Secretary, CIB&RC presented the agenda and item wise decisions taken by the RC are as under: -

2.1	Consideration of presentation of M/s M/s Varsha Bio Science and Technology Hyderabad for grant of registration for indigenous manufacturing of <i>Bacillius thuringiesis var kurstaki 0.50% WP</i> under section 9(3) (Strain designation: DOR Hyderabad, Accession No. INAIMCC B-01118).

	M/s Varsha Bio Science and Technology, Hyderabad made the presentation. RC deliberated and decided to consider the application to grant the registration under section 9 (3). However, RC also decided to approve registration at the same level of potency of the product as approved in the certificate of registration granted under section 9 (3b) considering the information submitted at the time of 9(3b) registration. Accordingly, applicant may be asked to submit revised label & leaflet.
2.2	Consideration of presentation of Mr. Ranjit Lal for Homeopathic agri inputs.
	RC heard the presentation of Sh. Ranjit Lal and noted that no information on the active
	principle, composition, mode of action, safety, bio-efficacy and its registration status in
	other countries of the listed products to control insects, pests and diseases have been
	provided/disclosed. Therefore, RC found that the application was lacking of above aspects.
2.3	Consideration of presentation of M/s Maharashtra Biocontrol Manufacturers Association Satna (MS) regarding simplified guidelines of Bio-pesticides for the already registered strain.
	M/s Maharastra Bio Control Manufacturers Association, Satna (MS) made the presentation. RC deliberated and decided that the existing relaxed guidelines do not require any further amendment w.r.t the consent/ authorization letter from the inventor of strain or undertaking by the applicant about the name of the inventor/ source of strain.
2.4	Consideration of presentation of CCFI for Minor change in formulation of pesticide.
	The committee decided to refer the representation/views of CCFI to the sub-committee constituted for minor change in formulation of pesticide.
2.5	Consideration of presentation of M/s Syngenta India Ltd., for framing checklist/guidelines for endorsing increase purity of Technical grade Active Ingredient" already registered in India u/s 9(3).
	M/s Syngenta India Ltd., presented regarding the registration application for <i>Thiamethoxam Technical 98% (w/w) Min.</i> as against their already registered product <i>Thiamethoxam Technical 97% (w/w) Min.</i> The applicant informed that FAO/WHO has already finalized specifications for <i>Thiamethoxam Technical 98% (w/w) Min.</i> Accordingly, the committee decided to seek data on detailed process of manufacture (Information about raw materials used, their Source of supply, Step-wise manufacturing process, chemical equation, formula, Flow sheet diagram of the process and effluent treatment method etc.), Physico-chemical properties of the product and Five batch analysis data from chemistry and toxicity data on acute toxicity and mutagenicity (AMES) for the product to be registered.
2.6	Consideration of presentation of from Director Agriculture Punjab regarding issue of import permit of Defoliant drop ultra 540 SC (Thidiazuron 30.51% + Diuron 15.25% SC) and PGR stance 110 SC (Cyclanilide 2.1% + Mepiquat chloride 8.4% w/w SC) for total mechanical picking project in Punjab.
	Representative from the Director Agriculture, Punjab informed that the product has been
	found useful in the total mechanical picking project in Punjab. The product has been used
	for the past 3 years under the project and the Govt. of Punjab intends to use it in coming
	season also in June -2018. The committee decided that details of the results of past three

	informed that the details of the results are available with M/s Bayer Crop Science Ltd,
	hence they may also be permitted to be associated during the presentation and the
	committee agreed to the suggestion
2.7 & 3.4	Consideration of representation of M/s Micro GO LLP, Tamil Nadu regarding technology developed for extension of shelf life of Tomato by mitigating microbial spoilage.
	M/s MicroGo LLP, Tamilnadu made the presentation for use of Chlorine Dioxide (ClO <sub>2</sub> ) on postharvest produce of tomato to enhance the shelf life. RC deliberated and noted that the product Chlorine Dioxide (ClO <sub>2</sub> ) is registered in FIFRA (USEPA) as pesticide. After deliberation, RC decided that the applicant should apply for the inclusion of the Chlorine Dioxide (ClO <sub>2</sub> ) in the Schedule to the Insecticides Act, 1968 and register the product as per the provisions of the Act.
3.0	Government Business
3.1	Exclusion of Neem products from insecticide schedule.
	The representation from M/s World Neem Organization and Others was deliberated by the RC regarding the problems faced by exporters of various neem products. After detailed discussion the committee decided that the concerned authorities may be informed that neem products (neem leaves, neem oil, neem kernels, neem cake) do not require registration for export for non-insecticidal purposes.
3.2	Application received under Star Export House for grant of registration.
	The committee decided that the certificate of registration may be issued to all applicants whose applications were received and found complete from all the angles for export purposes but the certificates were not issued in view of Public Noted vide F. No. 19-218/2017-CIR-I dated 27.11.2017.
3.3	Consideration of representation of M/s Penshibao Wang Pvt. Ltd., Bangalore for relaxed guidelines for registration soil micro-organism based pesticides under section 9(3) and 9(3b).
	The committee deliberated in detail and decided that no further relaxation in guidelines
	for registration for soil micro-organism based pesticides is required as most of such
	products are now also manufactured by chemical processes.
3.4	Consideration of representation of M/s MicroGO LLP, Tamil Nadu regarding technology developed for extension of shelf life of Tomato by mitigating microbial spoilage.
	The decision of this Agenda is as under Agenda Item No. 2.7.
