

**MINUTES OF 387th MEETING OF REGISTRATION COMMITTEE HELD
ON 27.03.2018 and 02.04.2018 at 10:00 AM IN THE CHAMBER OF DR. S.

The 387th Meeting of Registration Committee (RC) was held under the Chairmanship of Dr. S. K. Malhotra Agriculture Commissioner on 27.03.2018 and 02.04.2018 at 10:00 AM in Room No. 231, Krishi Bhawan New Delhi., Dr. P. K. Chakrabarty, ADG (PP), ICAR, Krishi Bhawan, New Delhi; Dr. K. K. At the outset, the Chairman welcomed the members and requested to APPA & Secretary, CIB&RC to take up the agenda, item-wise, for deliberation. APPA & Secretary, CIB&RC presented the agenda and item wise decisions taken by the RC are as under: -

	Committee deliberated the minutes of 386th meeting of registration Committee and confirmed the same.

2.0	<u>Presentation</u>
2.1	<p>Presentation of M/s Director, ICAR National Research Centre for Grape, Pune</p> <p>Dr. S.D. Sawant, Director, NRC Grapes (ICAR) presented their research finding on <i>Bacillus subtilis</i> strain DR-39 having properties for biodegradation of agrochemical residue in Grapes. The strain DR-39 has been identified by the institute on the basis of morphological, Biochemical and molecular analysis. The NRCG presented results of field testing of <i>Bacillus subtilis</i> strain DR-39 for its capabilities in bio degradation of various agrochemical residues associated with Grapes.</p> <p>RC deliberated the Agenda and noted that the request of NRC Grapes is for use of specific bacterial strain for biodegradation of pesticidal residues and not for any pesticidal purpose. Therefore, the RC is of the view that at first stage the applicant may be informed to seek the opinion from APEDA regarding permissible limits of this organism in Grapes if any and after the receipt of the opinion the matter may be presented to the Registration Committee.</p>
2.2	<p>Presentation of M/s Willowood Chemicals (Pvt.) Ltd., for export of Oxamyl Technical 95.80% w/w min.</p> <p>Committee deliberated and approved the proposal for import of Oxamyl Technical 95.80% w/w min. exclusively for export purpose.</p>
2.3	<p>Presentation of M/s Tropical Agro System Pvt. Ltd.</p> <p>RC deliberated on the request of M/s Tropical Agrosystem Pvt. Ltd., for permission for import of 100 kg of 1-MCP. RC deliberated on the issue and observed that the M/s Tropical Agrosystem Pvt. Ltd., has recently submitted the application for registration of 1-MCP. Even though there have been recommendation from State Government of Uttrakhand & Himachal Pradesh to allow import of the chemical for use on Apple during post-harvest period for enhancement of shelf life, RC is <i>prima-facie</i> of the view that the safety concerns associated with the product are required to be evaluated before allowing import of 1-MCP. Hence, the permission for import of the product at this stage is not supported by science based facts. RC also noted that a sub-committee constituted by RC is working on framing of guidelines for the product and desired that the guidelines should be finalized and submitted to RC expeditiously preferably within a period of one month and the same may be placed in the next RC meeting for consideration and appropriate decision. Further, considering the importance of the chemical as requested/recommended by the State Governments in enhancing the shelf life of Apple, RC decided to evaluate the application of M/s Tropical Agrosystem Pvt. Ltd., in a fast track mode, considering the interest of farmers in the relevant states in reducing the losses in post harvest.</p>
2.4	<p>Presentation of M/s PI Industries Ltd.</p> <p>The committee deliberated the request of the applicant as mentioned in their presentation regarding the Technical Indigenous Manufacture and Formulation Indigenous Manufacture of their product Bispyribac sodium. The committee further noted the concern of the applicant in view of the fact that they are supporting the “Make in India” initiative of the Government of India. The committee also observed that no specific guidelines are available for this particular category. In view of above RC decided to constitute an expert committee for the framing of the specific guidelines “Guidelines for registration of TIM (by the original registrant under Formulation Import category) with additional</p>
