

**MINUTES OF 388th MEETING OF REGISTRATION COMMITTEE HELD
ON 27.04.2018 AND 01.05.2018 IN THE CHAMBER OF DR. S. K.
MALHOTRA, AGRICULTURE COMMISSIONER, ROOM NO. 231, KRISHI
BHAWAN, NEW DELHI.**

Ltd. for grant of registration for formulation import of <i>Methoxyfenozide 21.08% w/w SC</i> u/s 9(3).</p> <p>The applicant presented the toxicity data and justification for variation in the chemical composition. The applicant further informed that the product Methoxyfenozide 21.08% w/w SC has been registered globally in more than 60 countries including USA, UK, China, Australia, Brazil, Japan, Canada, Germany, France, South Africa, New Zealand etc. and the registration for the same is being sought in India as well. The applicant also clarified that the same tox data has been submitted for global registration.</p> <p>The RC deliberated the agenda and decided to approve grant of registration for import of Methoxyfenozide 21.08% w/w SC for control of Leaf eating caterpillar, leaf minor and pod borer in Groundnut and Early shoot borer in Sugarcane.</p>

2.4	Presentation of M/s GSP Crop Science Pvt. Ltd. for grant of registration for Indigenous manufacture Pymetrozine Technical 98% w/w min u/s 9(3)
	The applicant representative presented the matter regarding chemical composition and impurities in the product. The committee deliberated the agenda and considering the explanations/clarifications given by the applicant approved the registration for Indigenous manufacture Pymetrozine Technical 98% w/w min.
2.5	Presentation of M/s SDS Ramcide Crop Science Pvt. Ltd. for enhancement of validity of registration for import of Imidacloprid Technical 94% w/w min u/s 9(4) TI
	Committee deliberated the presentation made by the applicant and did not find the explanation satisfactory. Committee further decided that the applicant may be asked to submit the document from the regulatory authority of the source country indicating the actual chemical composition of the Imidacloprid Technical along with the purity of a.i. and percentages of impurities registered.
2.6	Presentation of M/s PI Industries Ltd., on PB Rope L.
	Committee deliberated the presentation made by the applicant and noted that the technology which the applicant is trying to augment in the country and claimed to be a promising way for management of Pink Ball Worm. RC also noted that the product has already been granted registration u/s 9(3B) with permission for commercialization. The Pink Ball Worm is a serious issue coming up in major Cotton growing areas and hence RC desired the Secretariat should confirm the receipt of the application by the applicant. Considering the impact caused by Pink Ball Worm in Cotton, RC also decided to seek concurrence from DAC&FW/ICAR for granting priority in scrutiny of the application.

	<p>In compliance to the RC decision, the expert committee under the chairmanship of Dr. P. K. Chakrabarty, ADG (PP) submitted its report regarding requirements for grant of registration for indigenous manufacture of <i>Paecilomyces lilacinus</i>. The chairman of the expert committee presented the report. RC appreciated the efforts of the expert committee. The salient recommendation of the expert committee are as under.</p> <p>Registration of <i>P. lilacinus</i> strain Pl-01 may be allowed with following conditions. The applicant must submit</p> <ul style="list-style-type: none"> i) A strain of primary culture of <i>P. lilacinus</i> strain PL-01 with ICAR-NBAIM for DNA finger printing and long-term storage. ii) A second set of controlled temperature study at NBAIM, Mau to show that the strain ceases to grow at temp above 35°C. iii) A second set of intraperitoneal pathogenicity and eye irritation test from a GLP laboratory in support of its biosafety. iv) A second set of studies on paecilotoxin production from a DSIR/ NABL accredited/ Govt approved laboratory. v) MLST data from ICAR-NBAIM, Mau to determine recombination efficiency.

	vi) Four set of clinical reports of its workers by a panel of medical experts (comprising of ophthalmologist and ENT specialists from a recognized hospital) conducted on quarterly basis.

The committee also noted that Cycloxydin Technical is non-irritant to eyes. In view of this the committee decided that the applicant must be informed that the committee has decided not to process the application for registration for use in the country and the applicant may be advised to register such formulation of the technical which does not have serious eye damaging potential and can be used safety under the conditions of use in the country.
