

MINUTES OF 392nd MEETING OF REGISTRATION COMMITTEE HELD ON 29.08.2018 IN THE CHAMBER OF DR. S. K. MALHOTRA, ROOM NO. 231, KRISHI BHAWAN, NEW DELHI.
