

**MINUTES OF 395<sup>th</sup> MEETING OF REGISTRATION COMMITTEE HELD ON 20.11.2018 IN THE CHAMBER OF DR. S. K. MALHOTRA, ROOM NO. 231, KRISHI BHAWAN, NEW DELHI.**

The 395<sup>th</sup> Meeting of Registration Committee (RC) was held under the Chairmanship of Dr. S. K. Malhotra, Agriculture Commissioner on 20.11.2018 at 09:30 AM in Room No. 231, Krishi Bhawan, New Delhi. Dr. I.S. Hura ( Representative of Drugs Controller General of India, New Delhi); Dr. K. K. Sharma, Project Coordinator, AINP on Pesticides Residue, Division of Agriculture, IARI, New Delhi; Dr. Rohit Mishra, Assistant Industrial Advisor, Ministry of Chemicals and Fertilizer, Shastri Bhawan, New Delhi and Dr. D.D.K. <b>3.1</b>	<b>Judgment 10.09.2018 passed by Hon'ble High court of Kerala at Ernakulam in W.A. 1745 of 2018.</b>
	RC is apprised of the above judgment in which the Hon'ble High Court has passed in earlier that there is no requirement of Import Permit for the import of insecticide intended to be used for non insecticidal purposes. RC also perused the opinion of the ASG that the matter may be taken up in appeal/SLP be the Hon'ble Supreme Court. Since in some other matter W.A. 617, 630, 648, 649/2017 vide judgment dated 03.06.2018 the same Hon'ble Kerala High Court had upheld the policy of the Department of the RC regarding registration of insecticides to be imported for non insecticidal use by the virtue of an Import Permit. RC decided to take up the matter to the Supreme Court for adjudication after the approval of DAC&FW. A communication may be accordingly be put to DAC&FW.
<b>3.2</b>	<b>Issue related to Maharashtra Government on sale and distribution of pesticides.</b>
	A representation from Pesticide Industry Association relating to Maharashtra Government on sale and distribution of pesticides was placed before the RC. The committee deliberated the issue and observed that the matter relating to marketing (sale) of pesticide is within the domain of State Government Licensing Authority. RC also noted that the license for sale/distribution of pesticides is issued by the State Government as per provision of the Insecticides Act, 1968 and the Rules, 1971. Moreover, the Insecticides Act/ Rules framed there under does not prevent the State Licensing Authority to endorse information relating to marketing agency etc. Further RC also reiterated its stand conveyed to all States and UTs Director of Agriculture vide letter no. 17-167/99-CIR dated 13.05.1999. RC directed that CIB&RC may intimate to the concern association accordingly.

<b>6.1</b>	<b>Application of M/s PI Industries Ltd., for grant of registration for formulation import of <i>PB Rope L/PB Knot</i> under section 9(3).</b>
	RC deliberated the agenda in detail considering the following:- i) The product has already been registered under 9(3b). ii) RC also noted that similar substances have been exempted earlier by RC from the requirement of registration for IPM programmes for reducing population of pests (Stem borer) as per Agenda Item No. 2.2 in its 293 <sup>rd</sup> meeting held on 26.09.2008.

	<p>iii) RC in its 391<sup>st</sup> meeting accorded priority for processing the applications for registration of Gossyplure considering the following:-</p> <ol style="list-style-type: none"> <li>a. Pink Boll Worm (PBW) is notorious pest causing heavy losses to the Cotton crop.</li> <li>b. Recently in the wake of PBW attack in Maharashtra, cotton crop suffered medium to heavy losses due to break down of resistance in Bt Cotton and frequent dry spells during kharif-2017.</li> <li>c. Even Bt cotton varieties initially effective have become ineffective against PBW in Maharashtra and Other cotton growing states.</li> <li>d. As one of the IPM strategies for controlling the population of PBW, pheromone based mating disruption technology has proved useful world wide.</li> <li>e. In pursuance of a meeting on PBW management in cotton held on 05.09.2017 under the chairmanship of JS (PP), a committee was constituted with the representative from Central and Regional members with survey route from 6th to 12th November, 2017 to assess the mating disruption technology (PB Rope L) and infestation by PBW in the states of Gujarat, Maharashtra, Karnataka and Andhra Pradesh.</li> </ol> <p>iv) The relevant Guidelines provides that as regards formulation, no data are required unless it is added with some other pesticide.</p> <p>v) As per guidelines, the requirement of various data for registration of technical pheromones should be determined on case to case basis considering the chemistry, use pattern and toxicity of the pheromones. Accordingly, it was required to be processed collectively by the experts in Chemistry, Bio-efficacy and Toxicity.</p> <p>vi) The guidelines also clearly state that Pheromone used in solid matrix dispenses and having low annual use rates can be waived of sub-chronic toxicity studies, developmental toxicity studies and immunotoxicity studies.</p> <p>vii) RC noted that the applicant has submitted a certificate declaring authenticity of the sample and the toxicological studies which included Acute oral Rat, Acute dermal rat, Acute inhalation rat, Primary skin irritation Rabbit, Irritation to Mucous membrane, Skin sensitization to guinea pig, toxicity to bird (northern Bobwhite) toxicity to fish (Rainbow trout) and mutagenicity-AMES Test .</p> <p>viii) RC also noted that as per Bioefficacy data and ICAR comments, the use rate for Gossyplure (PB Rope L/PB Knot) is 140 gm a.i. in an area of 10 hectare and hence the low use rate per acre below 150 gm a.i. (as indicated in guidelines) is established.</p> <p>ix) Further RC also observed that as per guidelines the Lepidopterean Pheromones that are naturally occurring compound designated by an unbranched aliphatic chain (between 9 and 18 carbons) ending in an alcohol, aldehyde or acetate functional group and containing upto 3 double bonds in aliphatic backbones can be exempted from the sub-acute toxicity carcinogenicity, effect on reproduction and metabolism if their use rates do not exceeds 150 gm/acre/year with good agricultural practices. As such the product qualifies for exemption.</p> <p>In view of above RC decided to grant registration to Gossyplure (PB Rope L/PB Knot)</p>
