

**MINUTES OF 405th MEETING OF REGISTRATION COMMITTEE HELD ON
17.07.2019 IN THE CHAMBER OF DR. S. K. MALHOTRA, ROOM NO. 231,
KRISHI BHAWAN, NEW DELHI.**

The 405th Meeting of Registration Committee (RC) was held under the Chairmanship of Dr. S. K. Malhotra, Agriculture Commissioner on 17.07.2019 at 10:00 AM in Room No. 231, Krishi Bhawan, New Delhi. Sh. Rajesh Malik (Member), Plant Protection Advisor, Directorate of PPQ&S, Faridabad; Dr. Rajan, ADG (PP) as Special invitee, New Delhi (Member); Dr. S. P. Shani (representative of DCGI), New Delhi (Member); Dr. K. K. Sharma (Co-opted member), Project Coordinator, IARI, Pusa, New Delhi; and Dr. Sushil K. Khurana(Member Secretary), CIB&RC, attended the meeting. Following officers from the Secretariat of CIB&RC also attended the meeting to present their agenda and advises as and when required/or volunteered to provide the information during the deliberations.

At the outset, Chairman welcomed the members & experts and asked Secretary, CIB&RC to take up the agenda for deliberations. The decisions taken by the RC are as under: -

1.0	Confirmation of minutes of the 404th minutes of the Registration committee Minutes of 404 th RC meeting were confirmed with minor amendment w.r.t. agenda item no. 10.13 of 404 th RC, the Chairman of Crop grouping committee Dr. Chakraborty will continue till submission of final report.

2.0	<u>Presentation</u>
2.1	<p>Presentation by M/s Tropical Agrosystem (India) Pvt.Ltd.in respect of their application for grant of registration for the product 1-methylcyclopropene 3.3% VP under 9(3) FI category.</p> <p>The representatives of M/s Tropical Agrosystem (India) Pvt.Ltd made a presentation before the RC and brought following facts:-</p> <ul style="list-style-type: none"> • M/s Tropical Agrosystem Pvt. Ltd., has applied for registration of 1-MCP (3.3% VP) formulation import under section 9(3) of Insecticides Act. The product is stated to be registered in 40 countries including US, UK, Australia, Japan, Canada and many European and Latin American countries etc. No untoward incidence was reported during its utilization. The product is registered by US EPA under bio-pesticides category and also considered under GRAS. • The applicant explained about the active ingredient(technical) /intermediate(MUP-HAIP)/ and used product along with its delivery system as under: Active: 1 methylcyclopropene, 1-MCP- gas at room temperature - Purity of 98% minimum- flammable and unstable Manufactured in the USA. It's a continuous and integrated manufacturing process as not to isolate the 1-MCP gas in its pure state where it is unstable and degrades rapidly. Pure 1 methylcyclopropene flows only through a short section of pipe intermediate (MUP-HAIP) Intermediate: Manufacturing Use Product-High Active Ingredient Product (MUP-HAIP) nominal content of 4.5% 1-MCP powder (certified limit of 4.1 to 4.9% w/w)- prepared form pre 1-MCP by encapsulation with alpha-cyclodextrin. Stable powder. Commercial Product: 1-MCP 3.3% VP (SmartFresh) made from MUP-HAIP put into PVA water soluble pouches. Delivery System: water soluble pouches when mixed with water in a proprietary delivery device, releases 1-MCP gas which ensures post harvest benefit of enhanced storage and extended shelf life by blocking ethylene receptors. <p>1. Conductance of studies on technical compound</p> <ul style="list-style-type: none"> • In response to query regarding for non conductance of studies on counterpart technical compound of 1-methylcyclopropene 3.3% VP, with respect to toxicology and bio efficacy studies which are supposed to be carried out on counterpart technical compound, the presenter explained pure 1-methylcyclopropene (1-MCP) is a gas. When toxicity studies were initiated in early 2000, they were conducted in a unique situation where the gas was produced and tested at the same location (at Rohm & Haas USA), using special condition (because 1-MCP is hazardous, flammable and unstable at room temperature). Few toxicity studies, such as the acute, three month inhalation toxicity developmental toxicity, metabolism and rat bone marrow

	<p>micronucleus studies were conducted using pure 1-MCP gas where rats were directly exposed to the gas in situ.</p> <ul style="list-style-type: none">Because of safety concern restricting transport of the pure 1-MCP gas to CRO/test facilities, the subsequent required toxicological studies were conducted with the stable technical powder. This powder is called Manufacturing Use Product-High Active Ingredient Product (MUP-HAIP) with nominal content of 4.5% 1-methylcyclopropene (certified limits 4.1 to 4.9% w/w). The 1-MCP was generated from the MUP-HAIP powder to derive data on toxicity of other parameters. Therefore, due to hazardous nature, lack of feasibility to test on the animals and due to unstable nature of 1-MCP, many studies were conducted on the stable technical powder (MUP-HAIP) i.e. on 4.5% active ingredient. The applicant further informed that is reason why the studies related to bio-efficacy parameters were also carried out on MUP-HAIP 4.7% and 1-methylcyclopropene 3.3% VP also not have the data of fate and behavior treated crop produced and air. Applicant informed that detailed explanation with Annexure submitted on 7th July, 2019. Further, applicant informed that they had face to face meeting with bio-efficacy experts on Friday June 12, 2019 and informed that has the point raised by other experts is the same therefore, that point may be cleared in the RC meeting. Accordingly applicant submitted that persistence study on apple fruits was conducted with formulated product and has been already submitted. Study was conducted at single and double the rates, which 68 mg/m³ and 136 mg/m³. The residue level observed was BDL (Below Determination Level less than 0.01 ppm) at 0 and 3 hours after treatment at both single and double the rates. And applicant quoted that they submit the report for the ready reference at Annexure-II (as the residue was BDL at 0 hours at treatment, therefore same data may kindly be considered for MUP-HAIP. 1-MCP is highly volatile and its half-life in air is estimated to be 1.47 hrs. we hereby attach the report for the Atkinson calculation of the DT50 in air of 1-MCP. (Annexure-III) <p>1a. Data submitted by the applicant for 1-MCP (1-methylcyclopropene 3.3%) is still need clarification regarding fate and behavior in Air.</p> <p>Response: As per the submitted draft label and leaflet, under precaution following information are mentioned:</p> <p>No entry period/application time: 24 hrs</p> <p>Safe waiting period/ Restricted entry Period: 30 minutes after opening of the room vent out duration: 30 minutes. (Annexure- IV)</p> <p>It is not possible to ship the gas to animal test facility due safety restrictions. Also it is not possible to conduct GLP studies at the site where the gas is manufactured. Since there was no longer a way to get the animals and the gas on the same side, studies</p>

with 1-MCP gas were no longer possible. Earlier, while studies have been conducted in the past with the 1-MCP gas, they were conducted in the unique situation where the gas was produced and tested at the same location (Rohm and Haas Spring House Laboratory 727 Norristown Rd, Spring House, PA 19477, United States)

Considering the above facts and safety concern restricting transport of the pure 1-MCP gas to CRO/test facilities, the required toxicological studies on stable technical powder MUP-HAIP with nominal content of 4.5% 1-methylecyclopropene (certified limits 4.1 to 4.9% w/w) were accepted by the RC.

2. **The applicant has not submitted the study on “Development Toxicity on Rabbit” where in the requirement is for two mammalian studies one is on rodent and another in non-rodent where in rabbit is found most suitable animal and adequately mentioned in the Guidelines framed by RC.**

Response: A position paper prepared by expert toxicology group (Exponent, document no 1600907.000-6477 of June 6, 2017) was submitted by the applicant on this issue before RC. The position paper clearly stated the following facts;

Attempts were made to conduct study in rabbit by inhalation, oral and through diet pellets and all these attempts proved difficult and unfeasible to dose rabbit due to several reasons.

In view of only little differences in the toxicity conclusion of other studies conducted in rat and dog for various endpoints to toxicity- it was scientifically concluded that rabbit study for teratogenicity may not draw any different conclusion than what was drawn in rat teratogenicity study.

Thus, based on above keeping animal welfare reasons in mind, rat study was considered adequate for teratogenicity. The Indian guidelines for registration of 1-MCP and such other products for Post-Harvest Treatment (Report of Dr. B.N.S Murthy committee of 2018) has given waiver for toxicity studies if difficult to conduct.

The requirement is for two mammalian studies one is on rodent and another in non-rodent where in rabbit is found most suitable animal and adequately mentioned in the Guidelines framed by RC. But as stated above by the applicant that attempts proved difficult and unfeasible to dose rabbit. The RC referred & deliberated the report (Waiver for a second species (non-rodent) OECD 414 and found that rabbit cannot be satisfactorily dosed orally with MUP-HAIP (1-MCP) via gavage/capsule/dietary because of vehicle stability and tolerability issues. It was also noted from report that 1-MCP gas cannot be produced safely or insufficient quantities at test sites for a rabbit studies and exposure via aerosol to with MUP-HAIP (1-MCP). Considering OECD 414 report, the report of Exponent International Limited, (2017) and also Murthy committee recommendations, RC considered it for further discussion in forthcoming RC meeting with respect to waiver issue.

The study on Carcinogenicity cum chronic toxicity has not been submitted.</p> <p>Response: AgroFresh already presented conclusion from other regulators (EPA Report: 1-Methylcyclopropene (PC Code 224459), EU: DAR Report on 1-methylcyclopropene vol. 3. Annex B, B.6 June 2005) as the basis for granting waiver for these term toxicity studies.</p> <p>Why Carcinogenicity study was not submitted:</p> <p>No or negligible long-term human exposure anticipated</p> <p>No residues detected in Apple.</p> <p>No trigger for long term tox studies based on available animal studies.</p> <p>Not feasible to conduct a fresh study in animal due to physical nature and animal welfare regulations.</p> <p>Regulators across globe (EPA, EU, Canada, Japan, Australia etc) have accepted the waiver and granted registration based on available and submitted animal data.</p> <p>4. Applicant may kindly refer the issue of impurities with this compound, which have been claimed as carcinogenic in nature and same was pointed out earlier. The level of these was high in the specification as mentioned by applicant earlier. The clarification submitted by the applicant is not clear, more elaboration is required.</p> <p>Response: AgroFresh presented new European Commission review of 2019 of a revised 1-MCP specification bases on 5 batch reports (Please see the Renewal report that has been favourably voted in May 2019: Annexure IV). AgroFresh now manufactures a high pyre 1-MCP (98%) and therefore decrease the level of the two toxicologically (1-CMP and 3- CMP) relevant impurities to < 0.2g/ kg each. This is a refinement in the process. We confirm the same for India as well wherein the pre-registration sample submitted to CIL dated June 19, 2019 meets the above new specifications. On enquiry that whether ATR has been generated at CIL. In charge CIL informed that CIL itself is not competent to generate the ATR for this compound. They would have to send the sample for analysis at Hyderabad. The assessment of the risk related to the genotoxic impurities 1-CMP and 3-CMP is discussed. It is concluded that the presence of these two impurities at 0.2g/kg in the technical specification results in margins of exposure of 150,000 and 3,200,000 for 1-CMP and 3-CMP respectively, which are unlikely to be of safety concern for consumers.</p> <p>On top of it, the below quote from the recent EFSA opinion dated on May 2018 for the renewal of 1-MCP in Europe reinforces that the safety of 1-MCP for the intended</p> |

use as post-harvest plant growth regulator is demonstrated in absence of the carcinogenicity and chronic toxicity studies:

For 1-methylcyclopropene, a limited toxicological data set was submitted. No chronic or carcinogenicity studies were available, and a limited number of species was tested in short-term and teratology studies. Considering the results of the available toxicity studies, the representative uses of 1-methylcyclopropene and the physical nature of the active substance (very reactive gaseous compound), the limited data set was considered acceptable (EFSA Journal 2018; 16(6):5308)

- 4a. **Applicant my kindly refer the issue of impurities associated with this compound, which have been claimed as carcinogenic in nature.**

Response: AgroFresh presented new European Commission review of 2019 of a revised 1-MCP specification based on 5 batch report (see the renewal report that has been favourably voted in May 2019). AgroFresh now manufactures a high pure 1-MCP (98%) and therefore brought down the level of two toxicologically (1-CMP and 3- CMP) relevant impurities to < 0.2g/ kg each. This is a refinement in the process. We confirm the same for India as well wherein the pre-registration sample submitted to CIL dated June 19, 2019 meets the above new specifications.

Thus, AgroFresh explained all the above points in the earlier submission as well and further AgroFresh reiterates that whatever data and test reports submitted to CIM was the same as submitted and reviewed by other regulators in the past and this registration granted in more than 40 countries (eg USA, Canada, UK, Germany, France, Italy, Japan, China, New Zealand, Australia etc) based on these set of data. In support, AgroFresh presented the new EFSA conclusion (released May 24, 2018) which reiterated the safety use of 1-MCP based on the available toxicological data to make human risk assessments.

On referring the peer review of pesticides risk assessment of the active substance 1-methylecyclopropene RC noticed that assuming the highest non-dietary exposure at the acceptable operator exposure level (AOEL) of 1-MCP, the margins of exposure for 1-MCP and 3-CMP with the presence of these two impurities at 0.2 gm per kg in the technical specification is unlikely to be of safety concern. Further, the batches used for further toxicological studies support the proposed renewal specification but not the original reference specification. The RC was informed by the Secretariat that they have applied with the specification of active ingredient 96% with higher level of impurities in the form-1 (legal application) however they are committing the active ingredient at 98% with presence of with these two impurities at 0.2 gm per kg. RC decided to take a precautionary steps during generation of ATR

	<p>and the product will be kept under surveillance if it is accepted for registration. RC was apprised that CIL does not have the instrument to detect the same. It was decided that this issue will be discussed in the forthcoming RC meeting.</p> <p>4b. The applicant has informed as 1-MCP does not leave residue in apples:</p> <p>1-MCP MRLs have been either set up at the minimum detection limit of 0.01 mg/kg or, it has been judged not necessary to establish MRLs in countries such as Australia and the USA. On query the applicant informed that MRL Performa will be submitted shortly. They were further asked how they would drive the ADI value when the study on carcinogenicity cum chronic study has not been submitted. They responded they would drive it on the basis study on sub acute oral dog and would convert it by dividing with a factor two hundred. They were asked when the gas is inflammable and reactive gaseous compound how the safety measures by the general public. They informed that the post-harvest apple will be dealt by PCOs only. The applicant responded and a short video was shown to the committee.</p> <p>Following decisions were taken.</p> <ul style="list-style-type: none"> i. Applicant may be asked to submit fresh form-1 indicating the revised chemical composition of counterpart technical of 1-MCP 3.3% VP and duly filled MRL Performa. ii. The product will be dealt by PCOs only. iii. Incharge CIL may be requested for early generation of ATR. iv. The proposed label and leaflets may be presented before the RC for its approval or otherwise. v. The technical comments on 1-MCP may be sought from ICAR. vi. The Secretariat should bring complete agenda with facts in the forthcoming RC meeting in light of presentation made by the applicant.
