# MINUTES OF 415<sup>th</sup> MEETING OF REGISTRATION COMMITTEE HELD ON 11.05.2020 (15:00 Hrs) THROUGH VIDEO CONFERENCE

The 415<sup>th</sup> Meeting of Registration Committee (RC) was held under the Chairmanship of Dr. S. K.
