MINUTES OF THE 422nd REGISTRATION COMMITTEE MEETING HELD ON 23.10.2020 (10:00 Hrs) THROUGH VIDEO CONFERENCE.

The 422ndMeeting of the Registration Committee (RC) was held under the Chairmanship of Dr. S. K. Malhotra, Agriculture Commissioner & Chairman, Registration Committee on 23.10.2020 at 10:00 Hrs onwards through NIC video conference. Dr. Ravi Prakash, PPA, DPPQ&S, Faridabad; Dr. C. D. Tripathi, Professor Emeritus, Department of Pharmacology, VMMC and S J Hospital, New Delhi; Dr. Dr. S. P. Sahni, (Representative of Drug Controller General of India), New Delhi; Sh. Madhav Chakarborty, Joint Director & Regional Head, IIP New Delhi and Dr. J. P. Singh, Secretary, CIB&RC attended the meeting.

Experts/ Officers from the Secretariat of CIB&RC attended the meeting to present their agenda and volunteered to provide the assistance during the deliberations were Dr. Sushil K. The RC recalled its decision taken in its 420 RC meeting (vide agenda item no 4.1 Sr no 87, 88 and 89 at annexure 4.1.1). RC therefore desires that the applicant may be called for presentation in its next meeting and till then the CR is issued shall be kept in abeyance as certain issues need to be adequately addressed.

	 The presentation was made by a representative of M/s PI Industries. Polyoxin D Zinc Salt is a globally acclaimed bio chemical pesticide. It is derived from fermentation process by using natural microbes. The product is safe to environment and thus exempted from MRL. Clarified that Znso4 is used for stabilization purpose. It was also appraised that scrutiny is compete from bio efficacy, chemistry and packaging. Examination by toxicologist may be done early so that such green chemistries and new molecules are considered at priority. RC directed the Secretariat to bring complete agenda in RC meeting after complete examination .
2.2	Presentation by M/s Lanxess India Pvt. Ltd., for grant of import permit of Biocidal product (Biocheck 8064-P-SB).
	Presentation was made by M/s Lanxess India Pvt. Ltd., for grant of import permit of Biocidal product (<i>Biocheck 8064-P-S</i> . This biocide claimed to be applied in plastic commodities. RC is the opinion that presently biocide permits are issued with the condition that the product will be supplied to the paint industry and are subject to the outcome of the LPA No. 325/2019.
2.3	Presentation by M/s Asian Paints Ltd., for expedite the approval of <i>Deltamethrin 1% RTU</i> (insect control paint).
	 M/s Asian Paints Ltd., made a presentation. RC in its 402nd meeting approved change of the lead with zircomium + calcium drier in the chemical composition subject to sample for testing at CIL along with test methods, specification and accelerated shelf life study. It was appraised that on 26.6.2019 applicant submitted sample for testing purpose to CIL. The sample was lost by CIL and on 26 June 2020, samples were resubmitted to CIL with complete set of documents. RC took a serious view on negligence on handling of samples for testing at CIL. It was also appraised that CIL report is ready and satisfactory and directed to present the complete case in next RC for consideration without any delay.

Minutes of the meeting under the chairmanship of Sh. Atish Chandra, Joint Secretary (Plant Protection), Department of Agriculture Cooperation & Farmers Welfare in Room No 142, Krishi Bhavan, New Delhi to Discuss issues related to amendment in the Insecticides Rules, 1971 regarding Label and Leaflets dated 28.08.2020 at 11.00. AM (Reference - W.P.(c) No. 4136/2020 and W.P.(c) No. 4137/2020)

Joint Secretary (PP) welcomed the participants and mentioned that in the light of the observations of Hon'ble High Court this meeting has been convened to discuss and resolve the remaining issues related to amendment in rule regarding label and leaflets. It was briefed by JS (PP) that the issues related to printing of Labels in Regional Language, Secondary packing, time line etc has already been resolved and clarified in detail to address the concerns of the industries in the previous meeting held on 22.07.2020 and same were also agreed by the Registration Committee in 421th RC meeting held on 21.08.2020.

The following remaining issues were raised and deliberated upon:

- 1. The requirement on label regarding "read leaflet before use" may not be insisted in regional languages other than English and Hindi and language of label for small and ultra small packages should be fixed to English and Hindi languages only due to space constraints.
- 2. Secondary packing on small and ultra small pack sizes should be abolished.
- 3. As the pictograms (1cm x 1cm) occupy substantial space on small and ultra small pack labels, the pictograms should be provided on the leaflet and not on thelabel.
- 4. The requirement of minimum area for toxicity triangle of "one sixteenth of the area of the panel or four square cm whichever is greater" should be removed for small and ultra- small packslabel.
- 5. Option for editing of applications for amendments of label and leaflet that had been submitted prior to 2020 notification due to changes in the requirements of label in 2020 notification.

All the above issues were deliberated one by one.

The samples of pesticides containers taken up from the market of different pack sizes viz. 10ml (ultra-small), 50ml/grams, 100ml/grams(small) and 250ml/ grams(small) were duly exhibited to all the participants including petitioners to show the label requirements are already in place. During exhibition of the sample containers, it was noticed that brand name of the pesticides with pictures of vegetables, crops, design etc has taken substantial space on the label which may be reduced to easily accommodate the critical information given in the impugned notification .The video of these samples has already been submitted to be placed before the Hon'bleCourt.

On requirement of language it was clarified that in the view of linguistic diversity and benefit of the farmers/ end-users, the notification states that the "label shall be printed at least in English and Hindi languages unless stated otherwise". Therefore if a State insists on printing of label in any regional language in lieu of either English or Hindi, the same has to be complied with. Further, as evident from the exhibited market samples, presently in many samples the stakeholders are already printing information in Hindi, English and one or more regional languages on the labels of all pack sizes. The notification states to print the label in two languages only and thus, substantial space is available on label for printing all required information.

With regard to the issues of secondary packing, these have already been addressed in previous meeting held on 22.07.2020, however it is again reiterated that that the individual secondary packing has not been explicitly mentioned in the notification and Registration committee has also allowed multiple primary packs in a secondary pack in new cases of Registration being considered under the present Notification.

With regard to the issues of pictograms, these have already been addressed in previous meeting held on 22.07.2020, however it is again reiterated that pictograms have been an essential part or the label since its introduction on the labels. Moreover, it was informed that manufacturers are already printing these pictograms on all pack sizes of insecticides presently being sold in the market.

With regard to the issues of toxicity triangle and its size, these have already been addressed in previous meeting held on 22.07.2020, however it is again reiterated the toxicity

triangle is one of the crucial parameters providing the first hand information to the farmers / end- users about the acute toxicity or otherwise of the insecticides and it is already implemented on all pack sizes of insecticides presently being sold in the market.

With regard to the issues of option for editing of already submitted applications for amendments of label and leaflet, it was informed that there is no change in requirements of big pack label and information submitted by the stake-holders in online applications are for big labels only and same will be utilized for issuance of system generated labels of all pack sizes and hence no editing is required in applications submitted for amendments in label and leaflets. However, if still some firms hasany issues with regard to any additional submission, the same can be mailed to Secretariat of CIB&RC.

Since still some members raised the issue of availability of space on the label ,it was suggested that if any difficulty is faced by any stake holder to accommodate the information on the label, they may submit the information to CIB&RC for necessary design and art work , the cost of which will be borne by the applicant.

The meeting ended with thanks to the chair.
