	3. Date of implementation of the renewed policy/guidelines should be from the date as decided by the Central Government.
	2. The registrant should be encouraged to obtain technical registration along with formulation of FI/FIM. The existing guidelines shall be in force till the new guidelines are framed.
	 RC perused the Report of the Sub-Committee and decided that – 1. The registration of technical should be mandatory for all cases of registration of pesticides in case of Formulation import and Formulation indigenous manufacturing. The new guidelines shall be framed for the purposes.
