PUBLIC NOTICE

Subject: During Lock down due to COVID-19- provisional exemption from the requirement of submitting of notarized documents/ affidavits etc-reg.

As per checklist/guidelines formulated by the Registration Committee (RC), the applicant is required to submit affidavit etc duly notoarized by the notary, along with application under various categories of application. Further, the RC in its 412th meeting held on 18.12.2019 (vide agenda item no. 11.3) decided that in all the cases where the scan copy of affidavit is submitted online, the applicant should also submit original affidavit (hard copy) within 30 days from the date of online submission of application for processing the case. If the original affidavit is not submitted within the 30 days period the application shall be closed after apprising to the RC.

During lock down (due to COVID-19) several request have been received to provisionally exempt from the requirement of submitting of notarized documents/ affidavits etc due to non functioning of the Courts in the country.

The request has been considered and it has been decided that during the lock down period the documents submitted by the applicant may be accepted provisionally on self-certification of the authorized signatory. Further, the applicant along with requisite documents shall, also submit an Undertaking (in the enclosed performa) that they shall submit the required documents viz notarized documents, affidavits etc. with in 30 days after the lock down period is over.
