

Update on Industry & Policy issues

Shri Jitendra Mohan, Chairman Technical and Regulatory Committee informed the group that since the last GC meeting the Technical and regulatory committee has met to deliberate the mentioned issues.

- 1. Gazette Notifications Issued by Ministry of Agriculture & Farmers Welfare
 - Gazette notification 3908(E) for inclusion of Flumetylsulforim (ADAMA), Profluthrin (Sumitomo) and Quinoxyfen (Dow) in the Insecticides Schedule
 - Gazette notification 5010(E) for Restriction on Use of Glyphosate Order, 2022 for its use by Pest Control Operators (Writ petition challenging the notification submitted in Hon'ble High Court of Delhi on 15.11.2022). ACFI has filed a WRIT petition in the Hon'ble High Court of Delhi.
 - Gazette notification 790(E) for Draft Insecticides Amendment Rules 2022 for educational qualifications for employment of a technical person in technical and formulation manufacturing plant (Stakeholder comments to be submitted by November 24, 2022). The time given for implementation for companies already holding valid manufacturing license is 4 years from date of issuance of final notification.
- i. Doctorate in Chemistry or Agriculture Chemistry or Agriculture chemicals or Master of Technology or Master of Science in Chemical engineering or equivalent for manufacture of technical grade insecticides
- ii. Graduate degree in Agriculture or Science with Chemistry as one of the subjects for manufacture of insecticide formulation. To be discussed in the Technical & Regulatory Committee

WRIT on restricted use of Glyphosate from PCO only

Dr. Kalyan Goswami informed the group that ACFI has filled a WRIT petition in the Hon'ble High Court of Delhi and along the same lines CLI & CCFI has also filled the same.

Financials predicted for this are approx. 2 Cr. Which will be borne by the major stakeholders of Glyphosate.

Report on Jago Kisan Jago Awareness Campaign

ACFI launched a mass awareness campaign on 11th September 2022, Nagpur to aware farmers about optimal use of Crop Protection Chemicals. It was flagged of by Shri Nitin Gadkari, Union cabinet minister for Transport and Highways and Shri Abdul Sattar, Hon'ble Agriculture Minister of Maharashtra and various stakeholders including industry members and Dr. C.D Mayee, past Chairman of ASRB- ICAR, joined it.

ACFI has deployed five mobile vans in 5 districts of Maharashtra, namely, Amravati, Nagpur, Wardha, Chandrapur & Gondiya in the first phase (from September to October 2022). And later on the other districts to be covered are Aurangabad, Hingoli, Nanded, Beed, Buldhana, Yavatmal, Nashik, Dhule, Nandurbar and Ahmednagar

OBJECTIVE:

To educate the farmers and spread the message that by using the right pesticides their crop yield will increase significantly.

To buy agrochemicals with GST Bill only.

To consult the KVK Scientists, Agriculture officers, Agri Universities professors before buying any product.

To use the agrochemicals judiciously as prescribed in the product leaflet.

To create awareness against misbranded and counterfeit products.

CONCLUSION:

The farmers in Maharashtra are aware of the importance of agrochemicals in increasing and maintaining crop yield. But their concern was regarding the

(i)sub-standard and misbranded products that are there in the market. Most of the farmers cannot differentiate between a genuine and misbranded product, for which they depend on the dealers.

(ii)Day by day the required doze is getting increased as pests are not affected with prescribed dosage

The farmers are told by the dealers they will have to pay 18% extra cost on the product if they need the bill, thus they do not ask for the GST bill. Most of the farmers buy pesticides on credit basis from the dealer and they take advantage of this and refuse to give GST Bill.

The KVK scientists, Agri extension workers are not active in remote areas and are failing in educating and helping the farmers in choosing the right product for their crops, thus the farmers seek advice of the pesticide dealers.

The agriculture extension workers are also not working actively in educating them on identifying the difference between the genuine and sub-standard product. Even when the industry organizes kisan sanghosties they do not talk about menace of misbranded and counterfeit products. They only speak about their brands in promotion.

NEXT COURSE OF ACTION:

- 1. ACFI would deploy 5 vans from Hyderabad, Telangana with support from Shri RG Agarwal.
- 2. ACFI would deploy 5 vans from West Bengal with support from Shri Atul Churiwal.

ACFI Financial Update

Dr. Kalyan Goswami informed the group that ACFI has got the 12A registration which is granted by the Income Tax Department to get exemptions from paying income tax based on few compliance criteria to which we need to adhere.

Under this we need to spend 85% of our income on stewardship initiatives. Dr. Kalyan Goswami with the help of Shri Sanjay Aggarwal has to share a draft budget on this by the end of December 2022.

Finalizing Debate Show Date

It has been decided that the ACFI will held this debate show in the month of Jan 2023. ACFI secretariat and the Debate show committee will work out the other details and budget for the same and share it with the GC by 15th December 2022.

HR Issues

Dr. Kalyan Goswami raised his concern that the ACFI secretariat needs more manpower as the association is growing at a tremendous rate. It was suggested by the GC that ACFI will take consult industry experts like Dr. Kannungo for technical matter and will hire an administrative person from science background as well.

Any other point with the permission of the chair

ACFI will get a stall space in the next India Chem or any such relevant event for visibility and promotion.

ACFI will write a letter to the Ministry of Corporate affairs suggesting that agriculture extension and farmer awareness should also be considered under the CSR Guidelines.

ACFI will start an initiative "School on wheels" wherein a fully mobilized bus will go through India propagating good agricultural practices along with the facility of soil testing for farmers. Shri Sanjay Aggarwal will share the detailed proposal on this by 2nd week of December 2022.

Shri Jitendra Mohan, Chairman Technical and Regulatory Committee informed the group about the GSRs that have been issued by the Ministry of Agriculture & Farmers Welfare and actions taken by ACFI on them along with the agenda for the Technical and regulatory committee.

1. Gazette Notifications Issued by Ministry of Agriculture & Farmers Welfare

ØGazette notification 833(E) for Draft Insecticides (amendment), Rules, 2022 for revision in fee schedule.

ACFI has sent a representation of this to JS(PP) on 08th December 2022 (Ref. No.: ACFI/2022/063)

ØGazette notification 846(E) for Insecticides (Second Amendment), Rules 2022 for inspection of manufacturing facilities within six months of endorsement of a product in manufacturing license by Insecticides Inspector, sale of insecticides through ecommerce entity and qualification of pest control operator. The members agreed to the same.

Update on Industry & Policy issues

Shri Jitendra Mohan, Chairman Technical and Regulatory Committee informed the group about the GSRs that have been issued by the Ministry of Agriculture & Farmers Welfare and actions taken by ACFI on them along with the agenda for the Technical and Regulatory Committee.

- 1. Gazette Notifications Issued by Ministry of Agriculture & Farmers Welfare
- Ø Gazette notification 833(E) for Draft Insecticides (amendment), Rules, 2022 for revision in the fee schedule. ACFI has sent a representation of this to JS(PP) on 08th December 2022 (Ref. No.: ACFI/2022/063)
- Ø Gazette notification 846(E) for Insecticides (Second Amendment), Rules 2022 for inspection of manufacturing facilities within six months of endorsement of a product in manufacturing license by Insecticides Inspector, sale of insecticides through ecommerce entity and qualification of pest control operator. The members agreed to the same.
- Ø Gazette notification 701(E) for Draft Insecticides (Prohibition) Order, 2023 for banning of Dicofol, Dinocap & Methomyl, all formulations of Carbofuran along with label claims except 3% CG, all formulations of Monocrotophos along with label claims except 15% SG and deletion of label claims for Malathion, Quinalphos, Mancozeb, Oxyfluorfen, Dimethoate and Chlorpyriphos.

Shri Jitendra Mohan explained to the group that the products are banned on the basis of the data submitted by registrants which were scrutinized by the independent expert committee. Now based on the PIL filed by Vanashakti Hon'ble Supreme Court wants to know the process followed by the government and the criteria set to scrutinize the products. The Department will file a further affidavit explaining the basis on which action has been taken on only three pesticides out of 116 on 28th April 2023.

Ø Gazette notification 140(E) for Insecticides (First Amendment) Rules 2023 for educational qualifications for employment of technical person in technical and formulation manufacturing plant. Time given for implementation for companies already holding valid manufacturing license is 4 years and one year for other companies from date of issuance of final notification. The members agreed to the same.

ØGazette notification 173(E) for Draft Insecticides (Fifth Amendment), Rules, 2023 for change in date from December 31, 2022 to December 31, 2023 for implementation of educational qualifications for dealers and distributors. The members agreed to the same.

Ø Gazette notification 172(E) for Draft Insecticides (Fourth amendment), Rules, 2023 related to following amendments:

In the Insecticides Rules, 1971 (hereinafter referred to as the said rules), in rule 10, in clause (iii) of sub-rule (3A):

- a) the words "Indian Grain Storage Institute, Hapur and National Plant Protection Training Institute, Hyderabad" shall be substituted by the words "Indian Grain Storage Management & Research Institute, Hapur and National Institute of Plant Health Management, Hyderabad, respectively".
- b) in sub-clause (iii), following proviso shall be inserted: Provided that any person who apply for grant of license for the Pest Control Operations using only Glyphosate and its derivatives for such operations as prescribed shall undergo a training programme, meant exclusively for Glyphosate usage, from any of the following Institutions any State Agricultural University or Krishi Vigyan Kendra or National Institute of Plant Health Management, Hyderabad or State Agricultural Management and Extension Training Institute or Central or State Agricultural Research Institute or any other Government recognized university or institute or Central or Regional Integrated Pest Management Center (CIPMC) with NIPHM as the implementing nodal agency for course curriculum and monitoring of the training programme.

Ø Gazette notification 211(E) for Insecticides (Second Amendment), Rules, 2023 related to amendments in labelling requirements vide which following amendments have been made.

- a) Only English and Hindi languages are to be printed on labels
- b) Equal prominence shall be given to brand name and common name
- c) QR code shall be placed on primary or secondary pack as the case may be at suitable place where it is easy to scan
- d) Size of pictograms shall be half-square centimeter (0.5 cm \times 0.5 cm) in respect of labels of ultra-small packs only
- e) For ultra-small packs, multiple primary packs may be packed in one secondary pack and the manufacturer shall ensure leaflet and QR code be securely attached with each primary pack before packing them in one secondary pack
- f) For ultra-small packs, the dimensions of the toxicity square shall be not less than 2.25 square centimeters (1.5cm x1.5 cm)

Conditions

Conditions

- a) No registration certificate holder shall use a label or leaflet, which is not in accordance with the provisions of the Insecticides (Second Amendment) Rules, 2023, after a period of six months from the date of commencement of the Insecticides (Second Amendment) Rules, 2023
- b) No insecticides or its package bearing a label or leaflet, which is not in accordance with the provisions of the Insecticides (Second Amendment) Rules, 2023, shall be distributed, sold, exhibited for sale or stocked, after expiry of two years from the date of commencement of the Insecticides (Second Amendment) Rules, 2023 or its expiry date, whichever is earlier and this explanation shall cease to exist after expiry of the said period, unless otherwise directed.

The members agreed to the same.

1. Agenda of Technical & Regulatory Committee Meeting

Ø Update on Quality Control Order

Shri Jitendra Mohan has informed the group of mandatory BIS standards for 76 chemicals which are listed in the Rotterdam & Stockholm conventions and categorized as hazardous under the Manufacture, Storage and Import of Hazardous Chemical (MSIHC) Rules. Out of these, 9 Pesticide products like Carbofuran, Phorate, Dicofol, Aluminium Phosphide, Captan, Dimethoate, Malathion, Monocrotophos & Zinc Phosphide are either listed under international conventions and/or MSIHC Rules.

ACFI has sent the following comments to the Department of Chemical & Petrochemical on 24.03.2023

- a) BIS standards for the nine pesticides listed in Stockholm and Rotterdam Conventions and/or MSIHC Rules should be converted into Quality Control Orders.
- b) Registration of pesticide manufacturers with BIS shall be voluntary and not mandatory, in consonance with current practice.
- Ø Amendment in Chemistry data requirement in guidelines for registration of formulation containing more than 2 active ingredients

Shri Jitendra Mohan informed the group that in RC 336, the method of Analysis (a single clear analytical separation method of active ingredients) should be changed to Method of Analysis (individual method of analysis for each active ingredient or a single clear analytical separation method of active ingredients, whichever is available). The technical reason for this is that many-a-times it is very difficult to develop a single

Also, data on Chemical Interaction among the a.i. in the combination product is to be deleted as stability of the formulation can be established by ambient storage stability study. This study is not required for binary combinations.

It was decided that ACFI shall submit a representation on the above two points to CIB&RC.

Ø Update on Glyphosate

Dr. Kalyan Goswami informed the group that the gazette notification has been stayed up to July 19, 2023, by the Hon'ble High Court of Delhi & a curriculum for the training of PCO for use of glyphosate has been approved in the 445th RC Meeting.

The Secretariat of CIB & RC shall write a suitable communication to DA & FW for taking up the matter with the proposed Institutes/Organizations and also to take further appropriate steps for the effective implementation of the notification in terms of the observations of the Hon'ble High Court of Delhi.

ACFI shall communicate with DA&FW and CIB&RC about engaging with stakeholders on this matter in view of the undertaking given by the government in Hon'ble High Court of Delhi and also in view of the stay granted by the Court.

Ø Update on RDP & extension of patent tenure

Shri Jitendra Mohan informed the group that last week DPIIT has called on a meeting to discuss the issue of regulatory data protection where in ACFI has supported RDP of five years for new molecules, which are out of patent and yet to be registered in the country. With regards to Extension of Patent Tenure & Other Related Matters ACFI is of the opinion that there should be no extension of 20 years patent period.

Amendment in the section 3(d) of the Patents act to allow second Medical use:

Section 3 (d) of Indian patent act recites "the mere discovery of a new form of a known substance which does not result in the enhancement of the known efficacy of that substance or the mere discovery of any new property or new use for a known substance or of the mere use of a known process, machine or apparatus unless such known process results in a new product or employs at least one new reactant".

Explanation.—For the purposes of this clause, salts, esters, ethers, polymorphs, metabolites, pure form, particle size, isomers, mixtures of isomers, complexes, combinations and other derivatives of known substance shall be considered to be the same substance, unless they differ significantly in properties with regard to efficacy;

ACFI's Opinion: As per section 3(d) second medial use is not allowed in India under Indian patent act. If the second medical use is allowed in Pharma and Healthcare sector then it should also be allow in Agro-Chemical Sector.

Reform in India's Pre-grant opposition system:

The Section 25 of Indian Patent Act deals with the Opposition to the patents wherein,

Section 25(1) [pre-grant] recites "Where an application for a patent has been published but a patent has not been granted, any person may, in writing, represent by way of opposition to the Controller against the grant of patent on the ground—a) to k) (for details kindly refer Indian patent act)

Section 25(2) [post-grant] recites "At any time after the grant of patent but before the expiry of a period of one year from the date of publication of grant of a patent, any person interested may give notice of opposition to the Controller in the prescribed manner on any of the following grounds, namely:— a) to k) (for details kindly refer Indian patent act)

ACFI's Opinion: It has to be observed that while the opposition system provided in Indian patent system is a unique process to stop the frivolous and false patent, but it fails to stop the frivolous opposition filing under section 25(1). We observe that the term "any person" in section 25(1) if replaced by term "any person interested" then curtailing in frivolous opposition may be possible.

Also the time allowed for entertaining pre-grant opposition should be limited to only 6 months after publication of application in patent journal. Thereafter, no such pregrant opposition should be entertained.

A second issue with both Section 25(1) and Section 25(2) is the limitless, long procedures which is a burden on applicant and opponents also and this whole process defeats the purpose of Patent system. A fix timeframe of disposal of pregrant/post-grant opposition from the date of filing opposition by opponents should be introduced.

Reforms in the annual disclosure of working of patents (Form 27):

Section 146 requires that patentee/licensee should furnish to Indian patent office the information that the patented invention has been commercially worked in India. This information shall be furnished once in respect of every financial year on Form 27.

ACFI's Opinion: Despite of making it mandatory by IPO, Form 27 filing still fails to disclose actual working status of granted patents. Applicants are filing non-working status continuously 5-10 years after grant of patent. This need to be corrected if patent is continuously non-working for 5 years, then, it should be open to public for practice.

It is further suggested that the time for commercialization of patent should be 10 years from the day of grant of patent and 5 years from the day of registration granted in case of agrochemicals.

Disclosure requirements regarding foreign applications under Section 8 and disproportionate consequences of non - compliance.

Under Section 8 of Indian Patent Act, applicant has to furnish the information of filing a patent application outside India for the same or substantially the same invention and also requires to furnish the timely information of patent grant or refused in that country.

ACFI's Opinion: Even though Section 8 filing is a legal requirement, still applicants are delaying its filing under the ambit of rule 137/138. This practice is posing a problem to competitors and hampers the business prospects since every competitor needs to be fully informed about the foreign filing of Patent and its grant/refused status. Any non-compliance of section 8 should be seriously viewed by DPIIT.

Ø Reforms related to ease of doing business

Shri KS Thyagarajan elaborated that ACFI has been liaisoning with the Department of Agriculture & Farmers Welfare, NITI Ayog, CIB&RC and the Department of Chemical & Petrochemical on the following issues under ease of doing business.

- · To allow Commercialization in case of Technical import (TI) and Formulation import (FI) u/s 9(3b) -Provisional registration.
- · Simplifying certain procedures of endorsements at CIB to facilitate Ease of Doing Business.
- · Simplifying certain procedures for CIB relating to the Extension of validity of the technical import registration certificate thereby facilitating Ease of Doing Business.

He further explained the existing procedure as per 371 RC dtd. 16/12/2016 for 9(3) source approval



The legalization in the Indian Embassy delays the whole process and is not required at all, and after various meetings with the concerned departments, the government has agreed to foresee this step and instead accept notarized Apostille (Hong Kong).

Agro Chem Federation of India ACFI' launched a mass awareness campaign to aware farmers about the optimal use of Crop Protection Chemicals. Under this initiative, ACFI has deployed twenty mobile vans in Haryana, Maharashtra, and Telangana.

OBJECTIVE:

- To educate the farmers and spread the message that by using the right pesticides their crop yield will increase significantly.
- To buy agrochemicals with GST Bill.
- To consult the KVK Scientists, Agriculture officers, and Agri university professors before buying any product.
- To use the agrochemicals judiciously as prescribed in the product leaflet.

- To create awareness about modern technology like Drones.

ACTIVITIES DONE:

- The 20 campaign vans traveled in Haryana, Maharashtra, and Telangana with proper monitoring.
- ACFI with its members has organized various farmer meetings during this period of time.
- They have distributed awareness leaflets on things to remember while buying, using, spraying, and storing the plant protection chemicals.
- They have fixed posters in the villages regarding buying crop protection chemicals with the advice of KVK Scientists, District Agriculture officers & Agriculture University professors, etc.

FEEDBACK:

- The farmers are aware of the importance of agrochemicals in increasing and maintaining crop yield. But their concern was regarding the
- (i) Day by day the required doze is getting increased as pests are not dyeing with prescribed dozes

- (i) sub-standard and misbranded products are there in the market. Most of the farmers cannot differentiate between a genuine and misbranded product, for which they depend on the dealers.
 - The farmers are told by the dealers they will have to pay 18% extra cost on the
 product if they need the bill, thus they do not ask for the GST bill. Most of the
 farmers buy pesticides on a credit basis from the dealer and they take advantage
 of this and refuse to give GST Bill.
 - The KVK scientists, Agri extension workers are not active in remote areas and are failing in educating and helping the farmers in choosing the right product for their crops, thus the farmers seek the advice of the pesticide dealers.
 - The agriculture extension workers are also not working actively in educating them
 on identifying the difference between genuine and sub-standard products. Even
 when the industry organizes Kisan sanghosties they do not talk about the menace
 of misbranded and counterfeit products. They only speak about their brands in
 the promotion.

NEXT COURSE OF ACTION:

- ACFI and the industry need to organize various Kisan Sanghosties to spread awareness on judicious use and identify the difference between genuine and substandard products.
- ACFI also needs to work towards training the dealers to assist the farmers in selecting the best product for their crop and selling only the genuine product.
